3) Respect the confidentiality of the inmate;
4) Refrain from supplying or sending the inmate materials including, but not limited to envelopes, stamps,
pre-stamped envelopes, writing paper, writing implements;
5) Refrain from sending the Inmate any books, tapes, or items of this nature;
6) Refrain from supplying Inmate with my phone number, address, or any other information prohibited by the
Program;
7) Refrain from visiting Inmate or having ANY contact with him/her outside facility or while Inmate is incarcerated;
8) Refrain from contacting anyone whom the inmate might ask me to contact;
9) Refrain from revealing any damaging personal information as outlined in our guidelines;
10) Attest to not having been a victim or any accomplice of a crime with someone who is presently incarcerated as a
result of that crime.
11)Be familiar with the H&I "Do's and Dont's".
I understand that every letter I send into the facility where the inmate resides will be opened, copied and
checked for contraband. The content of the letter is to remain on topic with the outline of the Program of Narcotics
Anonymous and/or the Questions from the NA Step Working Guide.
Discretion will be exercised in writing about any matter that could be construed and jeopardizes the safety
and the security of the facility, its staff, its residents, this sub-committee, or anyone else.
I understand that failure to adhere to any of the aforementioned articles will result in cessation of my
participation in the Behind the Walls Sponsorship Sub-Committee Program and may put yourself and the whole
program at risk.
The Sub-Committee Chair will notify me when I am approved as a Sponsor and when I have been assigned
an Inmate at the appropriate time.
