Hello Family:

Behind the Walls is doing well. A bit of a slow down these last two months. Fire Season & Training is starting at the Nevada State Prisons, and Inmates are preparing for Pack Tests for placement throughout the summer. We have a very good placement of Sponsors since we got 15 new ones at the last Convention.

We still have a good amount of Inmates working steps by mail but 8 of them have reported they will work on fire crew in Calif and Nevada June - August this summer season. Because of this our letters have gone down already to nearly 55% or the normal amount. But our next Set of Prison packets are set to go out August 1, 2025.

As you may already know, Ashley our Vice Chair has stepped down and has returned to her home State of Virginia and I have gotten the other mailbox key back. The key will go to Susie since she will be training for Temp Vice Chair until someone else steps up or elections which take place next July.

The Qualifications and Duties for BTW Vice Chair are as follows:

"(Pg 4/ B)

B. Vice Chair:

- 1. Is elected by the group conscience of the Subcommittee (Every 2 years), via email and/or using Social Media, or Zoom with the Secretary taking tally and the Vice Chair and Secretary making all election posts and announcements. Web pages, social media or email can be used.
 - 2. Complete abstinence from all drugs for 3 years.
- 3. Must have one (1) year experience in Regional H&I service/1 year BTWSP Service or as an Area Chair or Area H&I Chair. Must have a working knowledge of the Twelve Steps and Twelve Traditions of Narcotics Anonymous through application.
- 4. Works with the Chairperson to ensure the smooth operation of the Subcommittee and steps in and performs the duties of the Chairperson when absent, learning the database and its use.
 - 5. Advises and coordinates with the webmaster for updating the Sierra Sage Regional Website.
 - 6. Service commitment shall be for a period of two (2) years.
- 7. Prepares a budget with the Chair to be approved by the subcommittee to then be submitted for the approval of the RSC for the upcoming year, in the month of November, no later than January.
- 8. Works with Chair when necessary to *receive* completed mail, prepare assignments, and send any and all packets and then assign sponsees to sponsors." (Prep Regional Reports)

Susie will be picking up and processing letters with me via the internet while I am gone (10 weeks) from Oct 1- December 15th, 25 - out of the Country. I will be attending the regional meeting, online, while in Germany in November as the internet is available. I have planned my trip around my commitment to the Sierra Sage Region. OFFENDER TABLET USE ADMINISTRATIVE REGULATION 753

SUPERSEDES: NEW REGULATION

EFFECTIVE DATE: PENDING

AUTHORITY:

RESPONSIBILITY

The Director of the Nevada Department of Corrections (NDOC and Department) is responsible for the implementation of this Administrative Regulation (AR).

The Wardens will ensure that their appropriate assigned subordinate supervisors have read and understand this regulation.

The Associate Wardens will ensure that their appropriate assigned subordinate supervisors have read and understand this regulation.

Supervisors will ensure that their appropriate subordinate staff members have read and understand this regulation.

Designated staff members will know, comply with, and enforce this regulation.

If, and where applicable, offenders will know and comply with this regulation.

- h. Tablet: An electronic device that will be loaned to each access to department approved content. offender when eligible, which contains applications and
- Unity Platform: Comprehensive wireless software that as music, video's, video games, e-books, media and other access to preloaded and downloadable applications such services for the offender population. operates on an independent secure network that provides

753.03 SECURE MESSAGING

Offenders may only send and receive secure messaging to and from those individuals who are on the offender's approved correspondence list and who have established an account with the service provider and have registered that offender to their account.

- 1. Offenders using secure messaging must adhere to all applicable provisions.
- 2. Secure messaging stamps are required and are available for purchase on the tablet using funds from the offender's Media Account.
- 3. Those individuals who are on the offender's approved correspondence list may purchase secure messaging stamps for offenders through the service provider which will be available to the offender for use in the offender's Media Account.
- 4. Secure messaging is subject to review by the department.
- 5. Offenders may not send or receive any attachments, photo's, audio, or any other documents.
- 6. Any offender found in violation of these provisions may be subject to discipline.
- 7. Any offender who is found to have multiple violations or abuse of secure messaging may have their tablet privileges revoked.

753.02 CONTENT

- 1. All available content has been established by the department and the service provider and is subject to change. Content may include music, movies, games, books, department publications.
- 2. All available content is subject to departmental approval.
- 3. Content determined to jeopardize safety and security will not be approved.

753.03 SECURE MESSAGING

Offenders may only send and receive secure messaging to and from those individuals who are on the offender's approved correspondence list and who have established an account with the service provider and have registered that offender to their account.

- 1. Offenders using secure messaging must adhere to all applicable provisions.
- Secure messaging stamps are required and are available for purchase on the tablet using funds from the offender's Media Account.
- 3. Those individuals who are on the offender's approved correspondence list may purchase secure messaging stamps for offenders through the service provider which will be available to the offender for use in the offender's Media Account.
- 4. Secure messaging is subject to review by the department.
- 5. Offenders may not send or receive any attachments, photo's, audio, or any other documents.
- 6. Any offender found in violation of these provisions may be subject to discipline.
- 7. Any offender who is found to have multiple violations or abuse of secure messaging may have their tablet privileges revoked.

753.04 EXCHANGING TABLETS AND ISSUED ACCESSORIES

- 1. If there is a problem with the tablet, offenders must notify the tablet vendor by opening a support ticket. A support representative will respond to the offender with troubleshooting steps or instructions. If they cannot remedy the issue, the representative will issue a Return Merchandise Authorization (RMA) number. As soon as the RMA number is assigned, the old device will be deactivated by the vendor. The old tablet must be packaged and returned to the vendor.
- 2. Individually packaged tablets for return will include any malfunctioning item as determined by the vendor.
- 3. Replacement accessories will not be included for replacement devices. The offender must keep the accessories received with the original tablet.
- 4. If an offender claims that their tablet has been lost or stolen, a shift supervisor or designee will be notified and an Incident Report will be generated to determine the whereabouts of the tablet. The offender will not receive a replacement tablet until the investigation is completed or the original tablet is found.
- 5. An offender may not receive a replacement if the outcome of the investigation proves the offenders neglected to follow the provisions set forth in this directive.

753.05 TRANSFERRED OFFENDERS OR OFFENDERS TEMPORARILY ABSENT FROM THE FACILITY

- A tablet or accessory received for an offender who has transferred from the facility shall be forwarded by the facility property staff to the appropriate receiving facility.
- 2. A tablet or accessory received for an offender temporarily absent from the facility (i.e., court, outside hospital, etc.) will be secured in the facility property room.

753.06 OPTING OUT

- An offender may choose to opt out of tablet use at any time. The offender must log into their account and select the opt out option. The tablet and any issued accessories must be returned to Property to be sent back to the vendor.
 - A. A CN 61002, Offender Property Status and Receipt will be completed and placed in the offender's property file.
 - B. If an offender elects to receive another tablet they must write a request to the facility property officer by utilizing a CN 9601, Offender Request Form. All content previously downloaded will not be on the new tablet once received and activated.
 - c. The Unit Administrator or designee may prohibit an offender from ordering another tablet if they have opted out previously.
 - D. Offenders who choose to opt out will not be refunded any monies in their Media Account.

753.07 FUNDING OF MEDIA ACCOUNT

- 1. Offenders are prohibited from adding money to another offender's Media Account.
- 2. Offenders may add money to their Media Accounts utilizing Attachment D, Special Request Form.
- 3. Any money deposited in the Media Account may only be spent on tablet services and cannot be transferred to another account or refunded at any time.
- 4. Offenders must use the tablet to check Media Account balances and receive notice of Media Account deposits. Any questions regarding Media Account balances and transactions must be directed to the service provider.
- 5. Offenders who elect to use a tablet and decide to opt out or are discharged will not be refunded any monies in their Media Account.

753.09 EXCEPTIONS

1. Any exceptions to the procedures in this Administrative Directive shall require prior written approval from the Commissioner.

- A. Eligible offenders may be provided with access to a tablet during their period of incarceration with the department from the service provider at no cost.
- B. Offenders at any Intake facility shall be incarcerated for a minimum of thirty (30) business days prior to being issued a tablet. Each tablet will come with a clear protective case, a set of earbuds, and a charger that has been reviewed and approved by the department. Replacement sets of earbuds and a charger may be purchased through commissary.
- c. Offenders shall only possess or use the tablet issued to them and are prohibited from lending or giving their assigned tablet to other offenders, which includes sharing passwords and personal identification numbers (pin).
- D. Tablets must only connect to the approved platform that is provided by the vendor and may not be connected to any other electronic device.
- E. Offenders shall only possess their tablets in their assigned housing unit. Tablet usage outside of designated areas is prohibited, unless authorized by the Unit Administrator, or designee.
- F. Use of a tablet is a privilege and may be suspended for abuse, misuse or other conduct.
 - An offender who intentionally damages a tablet shall be responsible for the repairs or replacement cost and is subject to discipline. Costs associated with the damage or repair may be taken from an offenders Media or Trust Fund Account.
- G. The service provider, in consultation with the department, reserves the right to deny a tablet to an offender who has intentionally destroyed or damaged a tablet in the past.
- н. Tablets that are malfunctioning will be addressed by the service provider via communication through the service provider to determine if the tablet needs to be repaired or replaced.
- 1. Tablets will transfer with offender property.
- J. Upon release from a correctional facility, or upon transfer out of the department's custody, the tablet shall be returned to the facility's property officer.

PURPOSE

This regulation contains and describes the policies and procedures governing the use of tablets available to eligible offenders. The utilization of the tablet assigned to an offender and use of tablets must be in accordance with these policies and procedures.

The department may provide offenders with access to tablets for the purpose of providing educational and/or program material and for the ability to download music, audiobooks, videos, video games, e-books, other media for a charge, and for any other legitimate penological purpose.

Definitions and Acronyms. For the purposes stated herein, the following definitions and acronyms apply:

- a. Content. A selection of applications and materials approved by the department for use on tablets that are provided to an offender. There are two types of content:
 - Downloadable: A selection of materials that can be added to a tablet, through the unity platform, at an offender's discretion and at a cost to the offender.
 - Preloaded: A selection of materials that may be included on the tablet upon issuance to the offender at no cost.
- b. Account password: A unique identifier used to log onto a user account. This includes all passwords associated with a user account or tablet.
- e. Service provider: The company with whom the department has contracted to provide software services. This service provider owns the rights to the service, content, devices and all other equipment associated with the product.
- d. User account: A user account established by the offender in order to access services.
- Media account: A prepaid account established with the service provider for the purpose of funding the downloaded content.
- f Secure Message: Electronic, computer-based, written communication(s), up to 6,000 characters, that are sent or received by an offender or a community member using applications managed by the service provider.
- g. Secure Messaging Stamp: An amount of money, set by the Department contract with the service provider,


